COMES NOW Jean Johnson, Special Deputy Receiver (SDR)'under contract to the Permanent Receiver of AmCare Health Plans of Texas, Inc., (AmCare Texas)'and AmCare Management, Inc., and MedImpact Healthcare Systems, Inc, who file this Joint Report and show:
